• Be a current member of LCU;


- Have never been convicted of an offence involving dishonest conduct;

Nominations must be in writing and be signed by the nominator and seconder, and counter signed by the nominee.

## LCU Contributes to the CSIRO Alumni Scholarship

LCU would like to Congratulate Ms. Brianna Ganly of the University of New South Wales for being awarded The CSIRO Alumni Scholarship in Physics for 2016.

Brianna is undertaking her PhD studies with CSIRO Mineral Resources in conjunction with the UNSW. Although the main objective of her thesis is to develop new methods for measuring the metal content in unprepared rock samples for the Australian mining industry, she discovered that the University of Guelph PIXE (Particle Induced X-ray Emission) group in Canada shares the same interests in improving measuring the element content of unprepared samples. The group is led by Professor Campbell, a world leading expert on PIXE, who is also a co-investigator on the Mars rover Curiosity's APXS instrument.

The scholarship will fund Brianna to visit Canada and perform particle size experiments with access to stars. As a result of her visit, Claire-Elise jointly published a specialised equipment, including a proton beam line which has recently been designed to emulate the Curiosity APXS as closely as possible. The results of these PIXE experiments will hopefully increase the understanding of The CSIRO Alumni Scholarship in Physics is a particle size effects in a way that can be applied to improving XRF analysis of ore.

The CSIRO Alumni Scholarship in Physics is awarded annually in commemoration of Drs John Dunlop, Don Price, Tony Farmer and Gerry Haddad, all former CSIRO physicists tragically lost in a helicopter crash in 2013. Colleagues, CSIRO alumni, friends and family congregated at CSIRO Lindfield on 21<sup>st</sup> March to celebrate the lives and legacies of the four great men and to congratulate this year's recipient of the scholarship. They were delighted to receive a report from Ms. Claire-Elise Green, the 2015 recipient, who used her scholarship to visit the Max-Planck-Institut für Radioastronomy to collaborate o their Chilean radio telescope data to study the birth of
